

**PhillipMart Announces Pre-IPO Share Price of  
 Kangda International Environmental Company Limited (Stock code: 06136)**

(Hong Kong – 3 Jul 2014) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Kangda International Environmental Company Limited** (“Kangda”; stock code: 06136) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Kangda** on PhillipMart were HK\$3.12 and HK\$2.89. The price closed at HK\$3.08 per share, 10% higher than its offer price of HK\$2.80. The price opened at HK\$2.89, with the most actively traded price of HK\$3.00 per share, and a turnover of 5,581,000 shares. The total trading volume reached 25,569,000 shares with total turnover of HK\$76,807,920.00. The final price of **Kangda**, to debut trading tomorrow has been fixed at HK\$2.80 per share.
