

**PhillipMart Announces Pre-IPO Share Price of
 Beijing Digital Telecom Co. Limited (Stock code: 06188)**

(Hong Kong – 7 Jul 2014) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Beijing Digital Telecom Co. Limited** (“**BJ Digital**”; stock code: 06188) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **BJ Digital** on PhillipMart were HK\$5.47 and HK\$5.35. The price closed at HK\$5.35 per share, 0.9% higher than its offer price of HK\$5.30. The price opened at HK\$5.40, with the most actively traded price of HK\$5.44 per share, and a turnover of 50,000 shares. The total trading volume reached 96,500 shares with total turnover of HK\$522,7650.00. The final price of **BJ Digital**, to debut trading tomorrow has been fixed at HK\$5.30 per share.
