

**PhillipMart Announces Pre-IPO Share Price of  
 Tian Ge Interactive Holdings Limited (Stock code: 01980)**

(Hong Kong – 8 Jul 2014) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Tian Ge Interactive Holdings Limited** (“**Tian Ge Interactive**”; stock code: 01980) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Tian Ge Interactive** on PhillipMart were HK\$6.13 and HK\$5.45. The price closed at HK\$6.13 per share, 16.1% higher than its offer price of HK\$5.28. The price opened at HK\$5.45, with the most actively traded price of HK\$6.00 per share, and a turnover of 2,261,000 shares. The total trading volume reached 8,386,000 shares with total turnover of HK\$50,104,480.00. The final price of **Tian Ge Interactive**, to debut trading tomorrow has been fixed at HK\$5.28 per share.
