

**PhillipMart Announces Pre-IPO Share Price of
 On Time Logistics Holdings Limited (Stock code: 06123)**

(Hong Kong – 10 Jul 2014) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **On Time Logistics Holdings Limited** (“**On Time Log**”; stock code: 06123) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **On Time Log** on PhillipMart were HK\$1.32 and HK\$1.22. The price closed at HK\$1.23 per share, 4.24% higher than its offer price of HK\$1.18. The price opened at HK\$1.22, with the most actively traded price of HK\$1.30 per share, and a turnover of 574,000 shares. The total trading volume reached 1,440,000 shares with total turnover of HK\$1,840,000. The final price of **On Time Log**, to debut trading tomorrow has been fixed at HK\$1.18 per share.
