

PhillipMart Announces Pre-IPO Share Price of China Fordoo Holdings Limited (Stock code: 02399)

(Hong Kong – 15 Jul 2014) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **China Fordoo Holdings Limited** ("**Fordoo"**; stock code: 02399) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Fordoo** on PhillipMart were HK\$3.90 and HK\$3.75. The price closed at HK\$3.75 per share,3.85% lower than its offer price of HK\$3.90. The price opened at HK\$3.90, with the most actively traded price of HK\$3.75 per share, and a turnover of 11,000shares. The total trading volume reached 13,000shares with total turnover of HK\$49,050.00 The final price of **Fordoo**, to debut trading tomorrow has been fixed at HK\$3.75 per share.
