

**PhillipMart Announces Pre-IPO Share Price of  
 Car Inc. (Stock code: 00699)**

(Hong Kong – 18 Sep 2014) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Car Inc. (stock code: 00699)** on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Car Inc.** on PhillipMart were HK\$9.84 and HK\$9.01. The price closed at HK\$9.72 per share, 14.35% higher than its offer price of HK\$8.50. The price opened at HK\$9.01, with the most actively traded price of HK\$9.40 per share, and a turnover of 3,662,000shares. The total trading volume reached 37,623,000shares with **total turnover of HK\$359,075,380.00**. The final price of **Car Inc.**, to debut trading tomorrow has been fixed at HK\$8.50per share.
