

PhillipMart Announces Pre-IPO Share Price of New Concepts Holdings Limited (Stock code: 02221)

(Hong Kong – 4 Jul 2014) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **New Concepts Holdings Limited** ("**New Concepts"**; stock code: 02221) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **New Concepts** on PhillipMart were HK\$1.05 and HK\$0.9. The price closed at HK\$0.94 per share,9.03% higher than its offer price of HK\$0.86. The price opened at HK\$1.05, with the most actively traded price of HK\$0.91 per share, and a turnover of 2,728,000shares. The total trading volume reached 6,112,000shares with total turnover of HK\$5,577,760.00. The final price of **New Concepts**, to debut trading tomorrow has been fixed at HK\$0.86 per share.
