

PhillipMart Announces Pre-IPO Share Price of ELL Environmental Holdings Limited (Stock code: 1395)

(Hong Kong – 25 Sep 2014) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **ELL Environmental Holdings Limited** ("**ELL Environmental"**; stock code: 01395) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **ELL Environmental** on PhillipMart were HK\$0.79 and HK\$0.60. The price closed at HK\$0.76 per share,38.18% higher than its offer price of HK\$0.55. The price opened at HK\$0.60, with the most actively traded price of HK\$0.75 per share, and a turnover of 7,360,000shares. The total trading volume reached 22,980,000shares with total turnover of HK\$17,151,950.00. The final price of ELL Environmental, to debut trading tomorrow has been fixed at HK\$0.55 per share.
