

PhillipMart Announces Pre-IPO Share Price of CGN Meiya Power Holdings Co., Ltd (Stock code: 01811)

(Hong Kong – 30 Sep 2014) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **CGN Meiya Power Holdings Co., Ltd** ("**CGN Meiya"**; stock code: 01811) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **CGN Meiya** on PhillipMart were HK\$2.06 and HK\$1.87. The price closed at HK\$1.95 per share,14.04% higher than its offer price of HK\$1.71. The price opened at HK\$1.88, with the most actively traded price of HK\$1.95 per share, and a turnover of 11,956,000shares. The total trading volume reached 70,134,000shares with total turnover of HK\$138,767,320.00. The final price of **CGN Meiya**, to debut trading has been fixed at HK\$1.71per share on 3 Oct.
