

PhillipMart Announces Pre-IPO Share Price of Nga Chun Holdings Company Limited (Stock code: 01462)

(Hong Kong – 15 Oct 2014) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Nga Chun Holdings Company Limited** ("**Nga Chun**"; stock code: 01462) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Nga Chun** on PhillipMart were HK\$1.40 and HK\$1.20. The price closed at HK\$1.22 per share,10.9% higher than its offer price of HK\$1.10. The price opened at HK\$1.30, with the most actively traded price of HK\$1.24 per share, and a turnover of 1,388,000shares. The total trading volume reached 6,576,000shares with total turnover of HK\$8,167,600.00 The final price of **Nga Chun**, to debut trading tomorrow has been fixed at HK\$1.10 per share.
