

PhillipMart Announces Pre-IPO Share Price of Austar Lifesciences Limited (Stock code: 06118)

(Hong Kong – 6 Nov 2014) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Austar Lifesciences Limited** ("**Austar Lifesciences**"; stock code: 06118) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Austar Lifesciences** on PhillipMart were HK\$3.97 and HK\$3.8. The price closed at HK\$3.89 per share,24.68% higher than its offer price of HK\$3.12. The price opened at HK\$3.8, with the most actively traded price of HK\$3.9 per share, and a turnover of 3,581,000shares. The total trading volume reached 15,864,000shares with total turnover of HK\$61,902,470.00. The final price of **Austar Lifesciences**, to debut trading tomorrow has been fixed at HK\$3.12per share.
