

## PhillipMart Announces Pre-IPO Share Price of Wai Chi Holdings Company Limited (Stock code: 01305)

(Hong Kong – 17 Nov 2014) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Wai Chi Holdings Company Limited** ("**Wai Chi"**; stock code: 01305) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Wai Chi** on PhillipMart were HK\$4.38 and HK\$3.20. The price closed at HK\$3.34 per share,9.24% lower than its offer price of HK\$3.68. The price opened at HK\$4.20, with the most actively traded price of HK\$3.55 per share, and a turnover of 395,000shares. The total trading volume reached 6,867,000shares with total turnover of HK\$24,500,130.00. The final price of **Wai Chi**, to debut trading tomorrow has been fixed at HK\$3.68 per share.
