

**PhillipMart Announces Pre-IPO Share Price of
 Feiyu Technology International Company Ltd (Stock code: 01022)**

(Hong Kong – 4 Dec 2014) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Feiyu Technology International Company Ltd** (“**Feiyu**”; stock code: 01022 on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Feiyu** on PhillipMart were HK\$2.30 and HK\$2.05. The price closed at HK\$2.29 per share, 4.09% higher than its offer price of HK\$2.20. The price opened at HK\$2.05, with the most actively traded price of HK\$2.30 per share, and a turnover of 148,500shares. The total trading volume reached 616,500shares with total turnover of HK\$1,374,420.00. The final price of **Feiyu**, to debut trading tomorrow has been fixed at HK\$2.20 per share.
