## PhillipMart Announces Pre-IPO Share Price of

## Nirvana Asia Ltd. (Stock code: 01438)

(Hong Kong – 16 Dec 2014) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Nirvana Asia Ltd.** ("**Nirvana Asia**"; stock code: 01438) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Nirvana Asia Ltd.** on PhillipMart were HK\$2.84 and HK\$2.27. The price closed at HK\$2.32 per share,22.67% lower than its offer price of HK\$3.00. The price opened at HK\$2.81, with the most actively traded price of HK\$2.45 per share, and a turnover of 2,568,000shares. The total trading volume reached 11,679,000shares with total turnover of HK\$28,022,320.00. The final price of **Nirvana Asia**, to debut trading tomorrow has been fixed at HK\$3.00 per share.
