

**PhillipMart Announces Pre-IPO Share Price of
 Canvest Environmental Protection Group Co. Ltd (Stock code: 01381)**

(Hong Kong – 24 Dec 2014) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Canvest Environmental Protection Group Co. Ltd** (“Canvest Env”; stock code: 01381) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Canvest Env** on PhillipMart were HK\$2.44 and HK\$2.33. The price closed at HK\$2.39 per share, 2.58% higher than its offer price of HK\$2.33. The price opened at HK\$2.33, with the most actively traded price of HK\$2.40 per share, and a turnover of 260,000 shares. The total trading volume reached 1,239,000 shares with total turnover of HK\$2,977,100.00. The final price of **Canvest Env**, to debut trading on 29 Dec has been fixed at HK\$2.33 per share.
