

**PhillipMart Announces Pre-IPO Share Price of  
 ShengJing Bank Co Ltd. (Stock code: 02066)**

(Hong Kong – 24 Dec 2014) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **ShengJing Bank Co Ltd.** (“**ShengJing Bank**”; stock code: 02066) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **ShengJing Bank** on PhillipMart were HK\$7.41 and HK\$7.30. The price closed at HK\$7.41 per share, 1.98% lower than its offer price of HK\$7.56. The price opened at HK\$7.30, with the most actively traded price of HK\$7.41 per share, and a turnover of 10,000 shares. The total trading volume reached 14,000 shares with total turnover of HK\$103,300. The final price of **ShengJing Bank**, to debut trading on 29 Dec has been fixed at HK\$7.56 per share.
