PhillipMart Announces Pre-IPO Share Price of Chun Sing Engineering Holdings Limited (Stock code: 02277)

(Hong Kong – 24 Dec 2014) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Chun Sing Engineering Holdings Limited ("Chun Sing"; stock code: 02277) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Chun Sing** on PhillipMart were HK\$0.73 and HK\$0.65. The price closed at HK\$0.68 per share, 13.33% higher than its offer price of HK\$0.6. The price opened at HK\$0.65, with the most actively traded price of HK\$0.69 per share, and a turnover of 1,330,000 shares. The total trading volume reached 3,065,000shares with total turnover of HK\$2,113,450.00. The final price of **Chun Sing**, to debut trading on 29 Dec has been fixed at HK\$0.6 per share.
