## PhillipMart Announces Pre-IPO Share Price of

Zuoli Kechuang Micro-finance Company Limited (Stock code: 06866)

(Hong Kong – 12 Jan 2015) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Zuoli Kechuang Micro-finance Company Limited** ("**Zuoli M-fin**"; stock code: 006866) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Zuoli M-fin** on PhillipMart were HK\$1.58and HK\$1.38. The price closed at HK\$1.50 per share,15.38% higher than its offer price of HK\$1.30. The price opened at HK\$1.38, with the most actively traded price of HK\$1.50 per share, and a turnover of 1,510,000shares. The total trading volume reached 1,844,000shares with total turnover of HK\$2,772,140.00. The final price of **Zuoli M-fin**, to debut trading tomorrow has been fixed at HK\$1.30 per share.
