

## PhillipMart Announces Pre-IPO Share Price of Jicheng Umbrella Holdings Limited (Stock code: 01027)

(Hong Kong – 12 Feb 2015) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Jicheng Umbrella Holdings Limited** ("**JC Umbrella**"; stock code: 01027) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **JC Umbrella** on PhillipMart were HK\$1.12 and HK\$1.00. The price closed at HK\$1.08 per share, 1.82% lower than its offer price of HK\$1.10. The price opened at HK\$1.12, with the most actively traded price of HK\$1.12per share, and a turnover of 80,000shares. The total trading volume reached 144,000shares with total turnover of HK\$156,640.00. The final price of **JC Umbrella**, to debut trading tomorrow has been fixed at HK\$1.10 per share.
