

PhillipMart Announces Pre-IPO Share Price of KTL International Holdings Group Limited (Stock code: 00442)

(Hong Kong – 10 Mar 2015) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **KTL International Holdings Group Limited** ("**KTL INTL**"; stock code: 00442) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **KTL INTL** on PhillipMart were HK\$4.20 and HK\$3.30. The price closed at HK\$3.96 per share,32% higher than its offer price of HK\$3.00. The price opened at HK\$3.30, with the most actively traded price of HK\$4.00 per share, and a turnover of 148,000shares.
