

**PhillipMart Announces Pre-IPO Share Price of
 Fuyao Glass Industry Group Co., Ltd. (Stock code: 03606)**

(Hong Kong – 30 Mar 2015) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Fuyao Glass Industry Group Co., Ltd.** (“**Fuyao Glass**”; stock code: 03606) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Fuyao Glass** on PhillipMart were HK\$18.80 and HK\$17.50. The price closed at HK\$18.620 per share, 10.83% higher than its offer price of HK\$16.80. The price opened at HK\$17.50, with the most actively traded price of HK\$18.50 per share, and a turnover of 3,050,000shares. The total trading volume reached 8,001,200shares with total turnover of HK\$147,762,784.00. The final price of **Fuyao Glass**, to debut trading tomorrow has been fixed at HK\$16.80per share.
