

**PhillipMart Announces Pre-IPO Share Price of
 Shanghai Haohai Biological Technology Co., Ltd. (Stock code: 06826)**

(Hong Kong – 29 April 2015) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Shanghai Haohai Biological Technology Co., Ltd.** (“**Haohai Biotech**”; stock code: 06826) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Haohai Biotech** on PhillipMart were HK\$64.05 and HK\$53.10. The price closed at HK\$56.25 per share, 4.66% lower than its offer price of HK\$59.00. The price opened at HK\$62.10, with the most actively traded price of HK\$55.00 per share, and a turnover of 99,500 shares. The total trading volume reached 788,800 shares with total turnover of HK\$45,001,415.00. The final price of **Haohai Biotech**, to debut trading tomorrow has been fixed at HK\$59.00 per share.
