## PhillipMart Announces Pre-IPO Share Price of D&G Technology Holding Company Limited (Stock code: 01301)

(Hong Kong – 26 May 2015) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **D&G Technology Holding Company Limited** ("**D&G Tech**"; stock code: 01301) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **D&G Tech** on PhillipMart were HK\$2.96 and HK\$2.48. The price closed at HK\$2.73 per share,19.74% higher than its offer price of HK\$2.28. The price opened at HK\$2.60, with the most actively traded price of HK\$2.55 per share, and a turnover of 1,662,000shares. The total trading volume reached 11,052,000shares with total turnover of HK\$28,889,400.00. The final price of **D&G Tech**, to debut trading tomorrow has been fixed at HK\$2.28per share.
