

PhillipMart Announces Pre-IPO Share Price of Yunnan Water Investment Co., Limited (Stock code: 06839)

(Hong Kong – 26 May 2015) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Yunnan Water Investment Co., Limited** ("**Yunnan Water**"; stock code: 06839) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Yunnan Water** on PhillipMart were HK\$7.50 and HK\$6.20. The price closed at HK\$6.55 per share,12.93% higher than its offer price of HK\$5.80. The price opened at HK\$7.25, with the most actively traded price of HK\$6.60 per share, and a turnover of 1,796,000shares. The total trading volume reached 10,058,000shares with total turnover of HK\$66,216,020.00. The final price of **Yunnan Waters**, to debut trading tomorrow has been fixed at HK\$5.80per share.
