

## PhillipMart Announces Pre-IPO Share Price of Huatai Securities Co Ltd. (Stock code: 06886)

(Hong Kong – 29 May 2015) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Huatai Securities Co Ltd.** ("HTSC"; stock code: 06886) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **HTSC** on PhillipMart were HK\$28.00 and HK\$27.00. The price closed at HK\$27.80 per share,12.1% higher than its offer price of HK\$24.80. The price opened at HK\$27.00, with the most actively traded price of HK\$27.80 per share, and a turnover of 1,753,200shares. The total trading volume reached 10,713,200shares with total turnover of HK\$296,258,050.00. The final price of **HTSC**, to debut trading on 1 June and it has been fixed at HK\$24.80per share.
