

## PhillipMart Announces Pre-IPO Share Price of 3SBIO INC. (Stock code: 01530)

(Hong Kong – 10 Jun 2015) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **3SBIO INC.** (Stock code: 01530) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **3SBIO** on PhillipMart were HK\$9.50 and HK\$9.00. The price closed at HK\$9.35 per share, 2.75% higher than its offer price of HK\$9.10 and price opened at HK\$9.25, with the most actively traded price of HK\$9.40 per share, and a turnover of 3,091,000 shares. The total trading volume reached 16,243,000 shares with total turnover of HK\$152,244,585.00. The final price of **3SBIO**, to debut trading tomorrow has been fixed at HK\$9.10share.
