

PhillipMart Announces Pre-IPO Share Price of China Greenfresh Group Co., Ltd. (Stock code: 06183)

(Hong Kong – 17 June 2015) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **China Greenfresh Group Co., Ltd.** ("**China Greenfresh**"; stock code: 06183) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **China Greenfresh** on PhillipMart were HK\$4.99 and HK\$4.65. The price closed at HK\$4.70 per share,0.21% lower than its offer price of HK\$4.71. The price opened at HK\$4.99, with the most actively traded price of HK\$4.68 per share, and a turnover of 170,000shares. The total trading volume reached 451,000shares with total turnover of HK\$2,119,440.00. The final price of **China Greenfresh**, to debut trading tomorrow has been fixed at HK\$4.71per share.
