

## PhillipMart Announces Pre-IPO Share Price of Pa Shun Pharmaceutical International Holdings Limited (Stock code: 00574)

(Hong Kong – 18 June 2015) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Pa Shun Pharmaceutical International Holdings Limited** (“**Pa Shun**”; stock code: 00574) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Pa Shun** on PhillipMart were HK\$1.35 and HK\$1.13. The price closed at HK\$1.13 per share, 7.38% lower than its offer price of HK\$1.22. The price opened at HK\$1.34, with the most actively traded price of HK\$1.18 per share, and a turnover of 2,442,000 shares. The total trading volume reached 14,492,000 shares with total turnover of HK\$17,215,320.00. The final price of **Pa Shun**, to debut trading tomorrow has been fixed at HK\$1.22 per share.
