## **PhillipMart Announces Pre-IPO Share Price of** AAG Energy Holdings Limited (Stock code: 02686)

(Hong Kong – 22 June 2015) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of AAG Energy Holdings Limited ("AAG Energy"; stock code: 02686) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **AAG Energy** on PhillipMart were HK\$2.93 and HK\$2.83. The price closed at HK\$2.87 per share,4.33% lower than its offer price of HK\$3.00. The price opened at HK\$2.93, with the most actively traded price of HK\$2.85 per share, and a turnover of 332,000shares. The total trading volume reached 822,000shares with total turnover of HK\$2,353,330.00. The final price of AAG Energy, to debut trading tomorrow has been fixed at HK\$3.00per share.
