

PhillipMart Announces Pre-IPO Share Price of Red Star Macalline Group Corporation Ltd. (Stock code: 01528)

(Hong Kong – 25 June 2015) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Red Star Macalline Group Corporation Ltd.** ("**RS Macalline"**; **stock code:** 01528) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **RS Macalline** on PhillipMart were HK\$13.24 and HK\$11.80. The price closed at HK\$13.22 per share,0.45% lower than its offer price of HK\$13.28. The price opened at HK\$12.50, with the most actively traded price of HK\$13.18 per share, and a turnover of 1,141,200shares. The total trading volume reached 4,062,000shares with total turnover of HK\$52,372,296.00. The final price of **RS Macalline**, to debut trading tomorrow has been fixed at HK\$13.28per share.
