

**PhillipMart Announces Pre-IPO Share Price of
 Vital Mobile Holdings Limited (Stock code: 06133)**

(Hong Kong – 25 June 2015) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Vital Mobile Holdings Limited** (“Vital Mobile”; stock code: 06133) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Vital Mobile** on PhillipMart were HK\$2.50 and HK\$2.40. The price closed at HK\$2.44 per share 1.61% lower than its offer price of HK\$2.48. The price opened at HK\$2.50, with the most actively traded price of HK\$2.44 per share, and a turnover of 232,000 shares. The total trading volume reached 796,000 shares with total turnover of HK\$1,937,860.00. The final price of **Vital Mobile Holdings Limited**, to debut trading tomorrow has been fixed at HK\$2.48 per share.
