

**PhillipMart Announces Pre-IPO Share Price of
 SKY LIGHT HOLDINGS LIMITED (Stock code: 03882)**

(Hong Kong – 30 June 2015) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of SKY LIGHT HOLDINGS LIMITED (“SKY LIGHT”; stock code: 03882) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for SKY LIGHT on PhillipMart were HK\$3.48 and HK\$3.32. The price closed at HK\$3.38 per share and its same with offer price. The price opened at HK\$3.40, with the most actively traded price of HK\$3.38 per share, and a turnover of 1,322,000shares. The total trading volume reached 3,610,000shares with total turnover of HK\$12,202,210.00. The final price of SKY LIGHT, to debut trading has been fixed at HK\$3.38per share on 2 July.
