

## PhillipMart Announces Pre-IPO Share Price of Tsaker Chemical Group Limited (Stock code: 01986)

(Hong Kong – 2 July 2015) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Tsaker Chemical Group Limited ("Tsaker Chemical"; stock code: 01986) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Tsaker Chemical on PhillipMart were HK\$4.00 and HK\$3.81. The price closed at HK\$4.00 per share,0.24% lower than its offer price of HK\$\$4.01. The price opened at HK\$3.99, with the most actively traded price of HK\$3.90 per share, and a turnover of 34,500shares. The total trading volume reached 83,000shares with **total turnover of HK\$326,800.00**. The final price of Tsaker Chemical, to debut trading tomorrow has been fixed at HK\$4.01 per share.
