PhillipMart Announces Pre-IPO Share Price of MAN KING HOLDINGS LIMITED (Stock code: 02193)

(Hong Kong – 2 July 2015) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of MAN KING HOLDINGS LIMITED ("MAN KING"; stock code: 02193) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for MAN KING on PhillipMart were HK\$1.30 and HK\$1.01. The price closed at HK\$1.24 per share,55% higher than its offer price of HK\$0.8. The price opened at HK\$1.01, with the most actively traded price of HK\$1.25 per share, and a turnover of 1,728,000shares. The total trading volume reached 9,924,000shares with total turnover of HK\$12,134,880.00. The final price of MAN KING, to debut trading tomorrow has been fixed at HK\$0.8per share.
