## PhillipMart Announces Pre-IPO Share Price of Chen Xing Development Holdings Limited (Stock code: 02286)

(Hong Kong – 2 July 2015) Phil**lip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Chen Xing Development Holdings Limited** ("**Chen Xing**"; stock code: 02286) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Chen Xing** on PhillipMart were HK\$3.12 and HK\$2.90. The price closed at HK\$3.10 per share, 3.33% higher than its offer price of HK\$3.00. The price opened at HK\$3.00, with the most actively traded price of HK\$3.10 per share, and a turnover of 215,000shares. The total trading volume reached 465,000shares with **total turnover of HK\$1,432,770.00**. The final price of **Chen Xing**, to debut trading tomorrow has been fixed at HK\$3.00 per share.
