PhillipMart Announces Pre-IPO Share Price of Guolian Securities Co.Ltd. (Stock code: 01456)

(Hong Kong – 3 July 2015) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Guolian Securities Co.Ltd. ("Guolian Securities"; stock code: 01456) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Guolian Securities on PhillipMart were HK\$7.40 and HK\$7.02. The price closed at HK\$7.23 per share,9.63% lower than its offer price of HK\$\$8.00. The price opened at HK\$7.30, with the most actively traded price of HK\$7.30 per share, and a turnover of 3159,000shares. The total trading volume reached 315,500shares with **total turnover of HK\$2,292,045.00**. The final price of Guolian Securities, to debut trading has been fixed at HK\$8.00per share on 6 July.
