## PhillipMart Announces Pre-IPO Share Price of Xinming China Holdings Limited (Stock code: 02699)

(Hong Kong – 3 July 2015) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Xinming China Holdings Limited ("Xinming China"; stock code: 02699) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Xinming China on PhillipMart were HK\$1.35 and HK\$1.25. The price closed at HK\$1.27 per share,11.19% lower than its offer price of HK\$\$1.43. The price opened at HK\$1.25, with the most actively traded price of HK\$1.27 per share, and a turnover of32,000shares. The total trading volume reached 50,000shares with **total turnover of HK\$63,780.00**. The final price of Xinming China, to debut trading has been fixed at HK\$1.43 per share on 6 July.
