

**PhillipMart Announces Pre-IPO Share Price of
 Luzheng Futures Company Limited (Stock code: 01461)**

(Hong Kong – 6 July 2015) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Luzheng Futures Company Limited (“Luzheng Futures”; stock code: 01461) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Luzheng Futures on PhillipMart were HK\$3.31 and HK\$2.21. The price closed at HK\$3.31 per share, 0.301% lower than its offer price of HK\$3.32. The price opened at HK\$2.85, with the most actively traded price of HK\$3.29 per share, and a turnover of 300,000 shares. The total trading volume reached 1,708,000 shares with **total turnover of HK\$5,374,300.00**. The final price of Luzheng Futures, to debut trading tomorrow has been fixed at HK\$3.32 per share.
