

## PhillipMart Announces Pre-IPO Share Price of Tianyun International Holdings Limited (Stock code: 06836)

(Hong Kong – 6 July 2015) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Tianyun International Holdings Limited ("Tianyun"; stock code: 06836) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Tianyun on PhillipMart were HK\$1.22 and HK\$1.14. The price closed at HK\$1.16 per share,9.38% lower than its offer price of HK\$\$1.28. The price opened at HK\$1.22, with the most actively traded price of HK\$1.22 per share, and a turnover of 4,000shares. The total trading volume reached 878,000shares with **total turnover of HK\$1,018,220.00**. The final price of Tianyun, to debut trading tomorrow has been fixed at HK\$1.28per share.
