

## PhillipMart Announces Pre-IPO Share Price of PuraPharm Corporation Limited (Stock code: 01498)

(Hong Kong – 7 July 2015) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of PuraPharm Corporation Limited ("PuraPharm"; stock code: 01498) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for PuraPharm on PhillipMart were HK\$5.80 and HK\$5.11. The price closed at HK\$5.50 per share,8.03% lower than its offer price of HK\$\$5.98. The price opened at HK\$5.20, with the most actively traded price of HK\$5.13 per share, and a turnover of 140,500shares. The total trading volume reached 652,500shares with **total turnover of HK\$3,416,025.00**. The final price of PuraPharm, to debut trading tomorrow has been fixed at HK\$5.98per share.
