

**PhillipMart Announces Pre-IPO Share Price of
 Universal Medical Financial & Technical Advisory Services Company Limited
 (Stock code: 02666)**

(Hong Kong – 7 July 2015) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Universal Medical Financial & Technical Advisory Services Company Limited (“Universal Medical”; stock code: 02666) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Universal Medical on PhillipMart were HK\$7.60 and HK\$5.82. The price closed at HK\$5.99 per share, 26.77% lower than its offer price of HK\$8.18. The price opened at HK\$7.60, with the most actively traded price of HK\$6.00 per share, and a turnover of 399,500 shares. The total trading volume reached 3,889,000 shares with **total turnover of HK\$23,796,715.00**. The final price of Universal Medical, to debut trading tomorrow has been fixed at HK\$8.18 per share.
