

## PhillipMart Announces Pre-IPO Share Price of Zhongzhi Pharmaceutical Holdings Limited (Stock code: 03737)

(Hong Kong – 10 July 2015) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Zhongzhi Pharmaceutical Holdings Limited ("Zhongzhi Pharmaceutical"; stock code: 03737) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Zhongzhi Pharmaceutical on PhillipMart were HK\$2.36 and HK\$2.21. The price closed at HK\$2.25 per share,8.54% lower than its offer price of HK\$\$2.46. The price opened at HK\$2.30, with the most actively traded price of HK\$2.31 per share, and a turnover of 95,000shares. The total trading volume reached 216,000shares with **total turnover of HK\$502,300**. The final price of Zhongzhi Pharmaceutical, to debut trading has been fixed at HK\$2.46 per share on 13 July.
