## PhillipMart Announces Pre-IPO Share Price of Golden Throat Holdings Group Company Limited (Stock code: 06896)

(Hong Kong – 14 July 2015) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Golden Throat Holdings Group Company Limited; stock code: 06896) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Golden Throat on PhillipMart were HK\$4.65 and HK\$4.53. The price closed at HK\$4.60 per share, its same with offer price. The price opened at HK\$4.55, with the most actively traded price of HK\$4.58 per share, and a turnover of 177,500shares. The total trading volume reached 424,000shares with **total turnover of HK\$1,947,115.00**. The final price of Golden Throat, to debut trading tomorrow has been fixed at HK\$4.60 per share.
