PhillipMart Announces Pre-IPO Share Price of

China Railway Signal & Communication Corporation Limited (Stock code: 03969)

(Hong Kong – 6 Aug 2015) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of China Railway Signal & Communication Corporation Limited ("China Crsc"; stock code: 03969) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for China Crsc on PhillipMart were HK\$6.50 and HK\$6.20. The price closed at HK\$6.40 per share, 1.59% higher than its offer price of HK\$\$6.30. The price opened at HK\$6.30, with the most actively traded price of HK\$6.35 per share, and a turnover of 70,000shares. The total trading volume reached 269,000shares with **total turnover of HK\$1,691,940.00**. The final price of China Crsc, to debut trading tomorrow has been fixed at HK\$6.30 per share.
