

PhillipMart Announces Pre-IPO Share Price of Wan Kei Group Holdings Limited (Stock code: 01718)

(Hong Kong – 10 Aug 2015) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Wan Kei Group Holdings Limited ("Wan Kei Group"; stock code: 01718) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Wan Kei Group on PhillipMart were HK\$0.98 and HK\$0.9. The price closed at HK\$0.96 per share,12.94% higher than its offer price of HK\$0.85. The price opened at HK\$0.93, with the most actively traded price of HK\$0.95 per share, and a turnover of 1,515,000shares. The total trading volume reached 6,495,000shares with **total turnover of HK\$6,150,850.00**. The final price of Wan Kei Group, to debut trading tomorrow has been fixed at HK\$0.85 per share.
