

PhillipMart Announces Pre-IPO Share Price of LEAP Holdings Group Limited (Stock code: 01499)

(Hong Kong – 1 September 2015) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of LEAP Holdings Group Limited ("LEAP Holdings"; stock code: 01499) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **LEAP Holdings** on PhillipMart were HK\$0.32 and HK\$0.265. The price closed at HK\$0.305 per share,22% higher than its offer price of HK\$\$0.25. The price opened at HK\$0.265, with the most actively traded price of HK\$0.305 per share, and a turnover of 1,650,000shares. The total trading volume reached 10,490,000shares with **total turnover of HK\$3,130,050.00**. The final price of **LEAP Holdings**, to debut trading tomorrow has been fixed at HK\$0.25 per share.
