

PhillipMart Announces Pre-IPO Share Price of LC Group Holdings Limited (Stock code: 01683)

(Hong Kong – 7 Sep 2015) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of LC Group Holdings Limited ("LC Group"; stock code: 01683) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for LC Group on PhillipMart were HK\$1.21 and HK\$1.10. The price closed at HK\$1.19 per share,19% higher than its offer price of HK\$\$1.00. The price opened at HK\$1.10, with the most actively traded price of HK\$1.19 per share, and a turnover of 156,000shares. The total trading volume reached 716,000shares with **total turnover of HK\$826,560.00**. The final price of LC Group, to debut trading tomorrow has been fixed at HK\$1.00 per share.
