## PhillipMart Announces Pre-IPO Share Price of China Shun Ke Long Holdings Limited (Stock code: 00974)

(Hong Kong – 9 Sep 2015) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of China Shun Ke Long Holdings Limited ("SKL"; stock code: 00974) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for SKL on PhillipMart were HK\$2.99 and HK\$2.90. The price closed at HK\$2.95 per share, 2.43% higher than its offer price of HK\$\$2.88. The price opened at HK\$2.99, with the most actively traded price of HK\$2.90 per share, and a turnover of 19,000shares. The total trading volume reached 23,000shares with **total turnover of HK\$67,020.00**. The final price of SKL, to debut trading tomorrow has been fixed at HK\$2.88 per share.
