PhillipMart Announces Pre-IPO Share Price of IMAX CHINA HOLDING, INC. (Stock code: 01970)

(Hong Kong – 7 Oct 2015) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of IMAX CHINA HOLDING, INC. ("IMAX CHINA"; stock code: 01970) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for IMAX CHINA on PhillipMart were HK\$32.85 and HK\$31.10. The price closed at HK\$32.60 per share, 5.16% higher than its offer price of HK\$\$31.00. The price opened at HK\$31.10, with the most actively traded price of HK\$\$2.50 per share, and a turnover of 55,800shares. The total trading volume reached 194,000shares with **total turnover of HK\$6,293,940.00**. The final price of IMAX CHINA, to debut trading tomorrow has been fixed at HK\$31.00 per share.
