

PhillipMart Announces Pre-IPO Share Price of Regina Miracle International (Holdings) Limited (Stock code: 02199)

(Hong Kong – 7 Oct 2015) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Regina Miracle International (Holdings) Limited ("Regina Miracle"; stock code: 02199) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Regina Miracle on PhillipMart were HK\$6.00 and HK\$5.70. The price closed at HK\$5.88 per share,5% higher than its offer price of HK\$\$5.60. The price opened at HK\$5.70, with the most actively traded price of HK\$6.00 per share, and a turnover of 28,000shares. The total trading volume reached 58,000shares with **total turnover of HK\$343,400.00**. The final price of Regina Miracle, to debut trading tomorrow has been fixed at HK\$5.60per share.
